## ANNUAL RENEWAL REQUIREMENTS TO MAINTAIN ACTIVE STATUS:

To renew your CPA/PA/NLO certificate as Active, each CPA/PA/NLO must complete:

- A total of 40 hours of CPE earned between October 1 and September 30
- Completion of at least 8 hours of Accounting & Auditing CPE
- Completion of at least 2 hours of qualifying Ethics CPE
- Completion of NO more than 12 hours of Personal Development CPE
- Completion of NO more than 10 hours earned by Nano Learning delivery method

## CATCH-UP CPE REQUIREMENTS TO ELECT ACTIVE STATUS AFTER ELECTING ANY OTHER STATUS:

To change your status to Active, each CPA/PA must complete:

- Completion of 40 hours of CPE per year not on active status, not to exceed a total of 120 hours
- Completion of at least 25% of the total required hours in Accounting & Auditing CPE
- Completion of at least 5% of the total required hours in qualifying Ethics CPE
- Completion of NO more than 30% of the total required hours in Personal Development CPE
- Completion of NO more than 10% of the total required hours by Nano Learning delivery method

Note: All required hours must be earned within the 3 year period prior to electing Active Status.

## CALCULATION OF CPE CREDIT BY DELIVERY METHOD:

Qualifying CPE	Minimum initial credit	After first credit has been earned, credit

Group	One (50 minutes)	One-fifth or one-half
Blended learning	One (50 minutes)	One-fifth or one-half
Self-study	One-half (25 minutes)	One-fifth or one-half
Nano-learning	One-fifth (10 minutes)	Not applicable (single nano-learning
		program is one-fifth credit)

\*NOTE – effective 10/1/19 there is no longer a cap on how many hours that can be earned through self-study CPE. The only delivery method that has a limit is Nano-learning (max of 10 hours).
